Midwest Foods will contact you within seven (7) days detailing your membership number; we will also keep you up to date throughout the year on the progress of your membership balance.

Orders can be placed and collected from the **3<sup>rd</sup> Monday in November**, through the New Year and until the **end of January**, to enable you to fully use the balance of your membership. **As an extra bonus, Midwest Foods will also make your funds available the week leading into Easter to assist with all your purchases.**

**TERMS & CONDITIONS OF MEMBERSHIP**

The Member agrees to be bound by the following terms and conditions:

1. The Member warrants that the information provided in this Membership Form is true and correct and that the Member is over the age of 18 years.
2. The risk of loss or injury to goods passes to the Member when the Member takes receipt of goods.
3. Credit is not provided to the Member.
4. Midwest Foods has a Privacy Policy which can be provided on request.
5. Payments being deducted from your nominated bank account will be on a weekly or fortnightly basis.
6. The minimum weekly or fortnightly bank deduction is \$10.
7. Orders can be placed from 20<sup>th</sup> November through to 20<sup>th</sup> January.
8. The membership balance is not refundable, but rather used for the purchase of products.
9. The membership card or proof of identification is to be shown when collecting your order.
10. Midwest Foods will give notice to the Member if it proposes to vary any of the Direct Debit Request Arrangements.
11. In the event of a Member requesting a deferment, or alteration to the Direct Debit Request arrangement, such request must be made to Midwest Foods by telephone no less than 24hrs prior to the proposed Direct Debit Request arrangement is to be executed.
12. Any requests to stop a Direct Debit Request arrangement temporarily or cancel a Direct Debit Request must be made in writing to Midwest Foods.
13. In the event of a dispute by a Member in relation to the Direct Debit Request, the dispute must be made in writing and Midwest Foods will respond in writing within 14 days.
14. The Member is to check with their nominated bank to ascertain if the bank account is available for direct debits before completing the Direct Debit Request.
15. It is the responsibility of the Member to have sufficient clear funds available in the relevant account by the due date to permit the payment of debit terms initiated in accordance with the relevant Direct Debit Request.
16. In the event that a payment falls on a non-business day, the Direct Debit Request will be processed on the next business day.
17. If a Direct Debit Request item is returned as unpaid, any applicable charges will be borne by the Member.
